SSBCI 2.0 PROGRAM OVERVIEW:

Executive Director Scatizzi presented the Executive Committee with an update on the Federal SSBCI 2.0 program, including recent guideline changes and the updated proposed allocation to the State of Missouri. Executive Director Scatizzi outlined select program requirements applicable funding recipients, along with an update on the efforts undertaken by the MTC Staff and the State of Missouri government officials in preparation of the program application and deployment of potential funding.

STATEWIDE STRATEGIC INITIATIVE UPDATE:

Chair Carter reported to the Executive Committee the following status updates of the Statewide Strategic Initiative: (a) MTC staff and Board members met for the third meeting of the Steering Committee on November 18, 2021, and (b) meetings are being planned for regions throughout the State of Missouri to receive feedback for planning for the state's needs in innovation. Overall, the process remains on schedule.

NEW BUSINESS: Executive Director Scatizzi reported the application period closed for the MOBEC Grant Program on November 16th. Twelve applications were received with a total request of approximately \$2.6 million. MTC Staff has begun the review and scoring process.
